A seat is confirmed on receipt of payment in full. Payment by credit card is preferred and a receipt is issued on payment. An invoice is provided on request for employer-sponsored seats or where a purchase order is required. If acceptance occurs thirty or more days before session one, payment is due within thirty days of acceptance and in all cases no later than fourteen days before session one. If acceptance occurs fewer than thirty days before session one, payment is due on acceptance. Written cancellation received thirty or more days before session one receives a full refund. Cancellation received fifteen to twenty-nine days before session one is subject to a fee equal to fifty percent of tuition. Cancellation received within fourteen days of session one, failure to attend, or withdrawal on or after the program start date results in forfeiture of full tuition, with no refund and no transfer of materials credit. Before session one, a seat may be substituted at no charge to another qualified executive in the same organization, subject to review. One deferral to the following cohort may be granted at Talk with Chip's discretion when requested in writing thirty or more days before session one. If Talk with Chip cancels the cohort, tuition paid is refunded in full. These terms follow standard executive education practice.
